5. The school will not pay salary and other benefits for its teaching and non-teaching staff less than State Government aided schools.
6. School will make rules and regulations for its employees and facilities will be given, like government aided madhyamik schools are providing for their employers.
7. School will follow all the orders, which will be circulated by the State Government time to time.
8. Records of the school will be maintained in the prescribed formats.
9. School fee of the students will be very less. Fee will not be more than Government Schools, which are running surrounding the Royal Academy. School will not charge building fee/caution money from the children.
10. Mr. Sanjay Chaubey "Chairman" of Royal Academy Educational Charitable Trust has expired on 27/10/2021 and Mr. Ajay Chaubey one of the trustee has expired on 12 Dec 2018.
